SAMPLE DOMESTIC RELATIONS ORDER Fire and Police Tier 1 Retired, Unmodified or Option 1 Allowance

NOTE: This sample order applies to divorcing parties, one of whom is a retiree under of the City of Fresno Fire and Police Retirement System (1st Tier), who selected an Unmodified allowance or Option 1 at the time of retirement.

This sample order is merely to assist attorneys in preparing a domestic relations order. It is not warranted that this sample order is appropriate in each individual case. The parties should always consult with their own attorneys before using this sample order. You may, of course, use other language; however, any order must be consistent with the provisions of the Fresno Municipal Code. Please note that neither the City of Fresno Fire and Police Retirement Board nor its agents are permitted to provide legal advice to you.

The parties must fill in the blanks in paragraphs 3, 4, 6, 7 and 9 before submitting this order to staff for review. Please contact Retirement staff for the information needed to complete paragraphs 6 and 9. Please read this sample order in conjunction with the Retirement Systems' community property pamphlet. The System reserves the right to modify this order.

- 1. <u>Intent</u>. This order is intended to satisfy the requirements of Article 17 of Chapter 2 of the Fresno Municipal Code concerning domestic relations orders. The parties acknowledge that this order is not subject to the federal Employee Retirement Income Security Act of 1974 or to amendments to ERISA ("ERISA"), such as the Retirement Equity Act of 1984. This order is entered pursuant to the California Family Code.
- <u>Claimant</u>. The name of the claimant to which this order applies is the City of Fresno Fire and Police Retirement System ("System"). The parties acknowledge that only the benefits provided by the System are affected by this Order, and that this Order cannot and does not create benefits or rights not provided by the System.

retirement was ______, payable over the life of the Retiree. That form cannot be, and is not, changed by this order, but the measuring life is changed as hereafter provided to be that of the Non-Member rather than the Retiree.

7. <u>Determination of Retiree and Non-Member's Share of Retirement Allowance.</u> The Retiree and the Non-Member have agreed that their respective percentage interests in the Retiree's retirement allowance are as follows:

- 8. <u>Non-Member's rights in the Post Retirement Supplemental Benefit ("PRSB").</u> The PRSB will be divided in the same manner and ratio as defined in paragraph 7 above. The parties acknowledge that the PRSB is not a guaranteed benefit and may increase, decrease, or be eliminated.
- 9. <u>Deferred Retirement Option Program ("DROP").</u> The Member, as of the date of separation, possessed a balance of \$______ in the Member's DROP account. The DROP account will be divided in the same manner and ratio as defined in paragraph 7 above.
- 10. <u>Retiree's Retirement Allowance.</u> After the receipt and approval of this order by the System, the System shall pay to the Retiree the percentage specified in paragraph 7 of the Retiree's retirement allowance in the same form as specified in paragraph 6 above.
- 11. <u>Non-Member's Retirement Allowance.</u> After receipt and approval of this order by the System, the System shall pay to the Non-Member a monthly retirement allowance determined as follows:
 - The System shall determine the total actuarial present value of the Retiree's total retirement allowance as of the date payments are to begin to the Non-Member, using the System's actuarial factors specified for this purpose at that time.

- b. The System shall multiply the amounts determined in a. above by the Non-Member's percentage specified in paragraph 7 above.
- c. The System shall convert the amount determined in b. above to a monthly annuity payable for the Non-Member's life in the form specified in paragraph 6 above, using the System's actuarial factors specified for this purpose at that time.
- d. The amount determined in c. above shall be payable monthly to the Non-Member in the form specified in paragraph 6 above.
- 12. <u>COLA</u>. Any cost of living adjustments hereinafter applicable to the Retiree's benefit if the dissolution had not occurred will, if not already in that form, be converted to a percentage increase. From the effective date of the cost of living increase, both the Retiree's and Non-Member's monthly benefit shall be increased by the percentage so determined.
- Separate Property. Any retirement benefit or allowance, or any portion of a retirement benefit or allowance that is not awarded in this order to the Non-Member shall be the sole and separate property of the Member.
- 14. <u>Statutory Limits</u>. In no event shall this order be interpreted to require the System to:
 - a. provide benefits with a greater actuarial value than it would otherwise pay, or
 - b. make payments to the Non-Member which are already required to be paid to another spouse under a prior order, or
 - c. provide any form of benefit or option not provided by the System.
- 15. <u>Retention of Jurisdiction.</u> The Member, the Non-Member, and the Court intend that this order meet all requirements of a domestic relations order under the Fresno Municipal Code and other applicable laws of the State of California, and the Court shall reserve jurisdiction to modify this order for the purpose of meeting or monitoring its implementation. The Court's reservation of jurisdiction shall be liberally

construed to effect the provisions of this order and to resolve any disputes that may arise among the parties and the System concerning benefit payments or any other aspect of this order. If any portion of this order is rendered invalid, illegal, unconstitutional or otherwise unenforceable, the Court reserves jurisdiction to make an appropriate adjustment to effectuate the intent of the parties. Any future attorneys' fees or costs incurred with respect to future modifications or interpretation of this order will not be assessed against the System.
