## MANUAL WORKER MEMBER OF THE EMPLOYEES RETIREMENT BOARD

NOTICE IS HEREBY GIVEN that an election will be held among the Manual Workers of the City of Fresno Employees Retirement System to elect a Manual Worker member of the City of Fresno Employees Retirement Board for the term ending June 30, 2014.

All Manual Workers of the City of Fresno Employees Retirement System are eligible to become candidates for membership on the Board. Any member desiring to become a candidate for election may obtain a nomination petition at the Retirement Office located at 2828 Fresno Street, Suite 201, Fresno, California 93721 or on the Systems website at [www.CFRS-CA.org](http://www.CFRS-CA.org).

Candidates may qualify for placement of their names on the ballot by filing with Office of the Secretary of the Retirement Board, on or before 5:00 p.m. on May 14, 2010, a nomination petition obtained from the Secretary of the Retirement Board, signed by *not less than 25 nor more than 35* of the manual worker members of the City of Fresno Employees Retirement System.

Ballots addressed to each members most recent home address contained in the System, may be mailed to all manual worker members of the City of Fresno Employees Retirement Systems on or before May 28, 2010. If you do not receive a ballot by June 7, 2010, please email or phone the Retirement Office to obtain a ballot. Ballots must be returned in the envelope accompanying the ballot addressed to the Board's independent auditor, and received by the auditor on or before 5:00 p.m. on June 11, 2010.

Friday	04/30/2010	First day to take out nomination petitions.
Friday	05/14/2010	Last day to file nomination petitions with Secretary.
Friday	05/21/2010	If only one candidate qualifies for placement on the ballot, the Secretary shall issue and post on the City Hall bulletin board a certification of that fact, and no election shall be held.
Friday	05/28/2010	Last day to mail ballots to voters.
Friday	06/11/2010	Last day to receive ballots.
Tuesday	06/15/2010	9:00 a.m. - Count Ballots.
Thursday	06/30/2010	Last day for Secretary for certification of results of election.
		Secretary shall post copy of certification on the bulletin board in the lobby of City Hall and shall file a copy thereof with the Board at its first meeting in July, 2010, for inclusion in the minutes.
Wednesday	07/14/2010	Newly elected employee Board member shall be given oath and assume office.
